

ABOUT THE COMMISSION ON NURSE CERTIFICATION

The Commission on Nurse Certification was established in 2007 and is the autonomous certifying body of the American Association of Colleges of Nursing (AACN). CNC works to establish a collaborative environment with evolving CNL stakeholders to improve health and healthcare delivery, promote certification and professional development and keep abreast of healthcare issues. To date, over 9,244 nurses have earned the CNL credential.

The CNL certification program is governed by the CNC Board of Commissioners (CNCBOC). The CNCBOC and staff are solely responsible for the policies and administration of the CNL Certification Program.



To govern the CNL certification activities and promote CNL practice.

Leadership, certification standards, professional development, and collaboration.

To establish a collaborative environment with evolving CNL stakeholders to improve health and healthcare delivery, promote certification and professional development and keep abreast of healthcare issues.



CNL CERTIFICATION


The pool of certified CNLs continues to grow substantially each year. Since 2006, a total of 9,244 nurses across the United States and its territories have earned the certified CNL credential. At the state level, California has the largest number of active certificants with 1,507 certified CNLs. In FY2022, 548 candidates successfully passed the CNL certification examination. Among those examinees, the pass rate among first timers was 71 percent. The following is a breakdown of the growth of certified CNLs from 2006 through the end of FY2022.




Number of Nurses Who Have Earned the CNL Credential since 2006 by Region



Total Number of Nurses who are CNL certified




Earned CNL per Program Model as Provided by the Program Director since 2010

Digital Badging

CNC's digital badging program is attracting widespread participation. Since the program's inception in December 2019, 9,138 digital badges have been issued via the Credlye's Acclaim platform. In FY2022, 517 digital badges were issued. Digital badges are valuable professional tools as they enable CNLs to list verified qualifications on email signatures, digital resumes, and social media sites such as LinkedIn, Facebook, and Twitter.



CNL Practice Exam

CNC's Clinical Nurse LeaderSM Practice Exam continues to gain interest among CNLs. In FY2022, 306 one-month and three-month subscriptions were purchased. Developed in collaboration with Clinical Nurse Leaders and Gray Matter Publishing, Inc./TestRun, this exam is an insightful tool for CNLs preparing for CNC's certification exam. CNLs are able to take multiple practice tests, a full practice exam or multiple short 10 question quizzes, and view progress reports that help CNLs identify areas of strengths and weaknesses.

CNC ADMINISTRATION AND GOVERNANCE



CNC's COVID-19 Protocol

CNC continues to make the safety of staff and its constituents a priority. From March 2020 to March 2022, the staff operated on a telework basis. In March 2022, it transitioned to a hybrid work model. We remain diligent in providing up-to-date information on the pandemic's impact to CNC's CNL Certification Program through our COVID-19 Information webpage at AACN.org/CNL.

Exam Administration and COVID-19 Protocol. At the height of the pandemic, Prometric SMT required exam candidates to wear an approved face covering and show proof of COVID-19 vaccination in order to sit for the exam at testing centers throughout the country. In May 2022, Prometric SMT gradually removed mask mandates at testing facilities.

National Accreditation



The National Commission for Certifying Agencies (NCCA) is the authority on accreditation standards for professional certification programs. The NCCA helps ensure the health, welfare, and safety of the public through the accreditation of individual certification programs that assess professional competency. Based on sound principles, NCCA standards are optimal and comprehensive criteria for organizational process and performance. They are broadly recognized, objective, and set current benchmarks for certifying bodies to achieve and by which they operate.

CNC's CNL Certification Program is nationally accredited by NCCA. In FY22, CNC continued to maintain NCCA accreditation. Maintenance of our accreditation involved submission of documentation and policies demonstrating compliance with NCCA standards. Achieving and maintaining NCCA accreditation demonstrates CNC's commitment to adding value to the CNL Certification Examination and showcases to the healthcare community that certified CNLs and the CNL program adhere to the highest certification standards.

CNC is due to renew its NCCA accreditation by August 31, 2023.

PROFESSIONAL DEVELOPMENT

2022 Virtual CNL Research Symposium

CNC's 2022 Virtual CNL Research Symposium - *The CNL Role: Imperative during a Public Health Crisis*, was held on February 16, 2022. The symposium is a pre-conference workshop to the CNL Summit that focuses on the CNL's role in data collection, evaluation for reporting clinical outcomes, and quality improvement. It united faculty, practicing CNLs, students, healthcare administrators, nurse executives, and others in San Antonio to discuss the CNLs role in evidence-based practice and outcomes.

Exhibiting

CNC is committed to promoting the value of CNL Certification to all stakeholders. In doing so, CNC staff exhibited via virtual conferences to help bring awareness of the certified CNL credential and the importance of certification.

STRATEGIC ALLIANCES

Members of the CNCBOC performed a crosswalk of AACN's Competencies and Curricular Expectations for Clinical Nurse LeaderSM Education and Practice against The Essentials: Core Competencies for Professional Nursing Education. Results concluded that over 62% of the CNL competencies were aligned with the Essential's Level 2 Model.

In addition, the CNCBOC recommends the update of AACN's 2013 CNL Competencies so that they align with the Essential's Level 2 competencies.



CNC also submitted a letter of intent for formal recognition by the American Nurses Association of the Clinical Nurse Leader as an advanced nursing practice specialty. The CNCBOC and the Clinical Nurse Leader Association Board of Directors have agreed to collaborate on this 18–24-month project.

FINANCIAL SUMMARY

In FY2022, CNC's total revenue earned was \$639,722.91, which is comprised of exam registration fees, renewal fees, symposium registration fees, and miscellaneous income. Expenses totaled \$546,666.14, which include program expenses, organizational management, and general expenses. These activities resulted in a fiscal year net asset of \$93,065.77.
