Collaborating on LPN to BSN Academic Progression: Four Schools with Grant Funding to Diversify the Nursing Workforce Sabal A-C

A statewide survey of licensed practical nurses (LPNs) in 2019 found that more than 80% of responding LPNs wanted to continue their education to become an RN and identified barriers to their academic progression. Based on the study findings, four Washington state nursing programs including one private university and three community colleges collaborated to obtained private foundation funding to develop and implement LPN to BSN programs. Collaboration activities included faculty development, development of holistic admissions presentations for prospective students, simulation education, and evaluation of each cohort as they progressed through their respective programs. Many lessons have been learned about addressing adult learning needs of very diverse post-licensure LPN-to-BSN students. These include varied skills upon entry, guiding experienced LPN students to being an RN student, and challenges of meeting clinical requirements of employed students. Outcomes include high retention and graduation rates, high NCLEX pass rates, student satisfaction, and student diversity well beyond the general RN population. As the number of traditional BSN students wane due to demographic shifts, schools should looked to LPNs as a pool of potential students to maintain enrollment and meet the workforce demand for diverse BSN graduates.
