The National Council for State Boards of Nursing (NCSBN) reports over 600,000 registered nurses are expected to leave the profession by 2027. Emphasis of the presentation will be shared from phase four, the qualitative portion of the study. A NGRN entering the workforce at this time meets a tremendous influx of challenges given the dynamic nature of the current healthcare system. How nurses were taught a decade ago does not match the professional expectations of practice on top of the challenges in nursing we have faced since the pandemic. This study assessed the impact on nursing students, faculty, and administrators during the pandemic to include the resulting outcomes. Based on the experiences, important lessons learned and how it impacts nursing education will be shared. The themes from this study captured the humanness of nursing education, fostering salience through turmoil, and new horizons for healthcare.
