# Case Study 1

# Ms. T.: Need for Palliative Care at the Time of Diagnosis

Ms. T. is 70 years old, is a retired school teacher, lives alone, and her only family is a son who lives out-of-state. She was diagnosed last week with advanced pancreatic cancer and is planning to start chemotherapy next week. She is experiencing severe abdominal pain, nausea and vomiting and is admitted to the hospital. You are the nursing student assigned to her care today. The oncologist has just seen the patient and has told her he would like to have the hospital's palliative care team see her today. As you are helping her with her a.m. care, Ms. T. says to you, "Why do I need a palliative care team? I thought palliative care is just for people who are dying."

## **Discussion Questions:**

- 1. Why might Ms. T. be appropriate for palliative care?
- 2. What services might palliative care be able to provide for Ms. T.?
- 3. How do you explain the concept of palliative care to Ms. T.?

Instructions: discuss how and when these might be used in your teaching or within your program

- 1. Arrange for participants to attend an interdisciplinary palliative care team meeting. In class, post-conference, or seminar, discuss the roles of various team members. Discuss the differences between interdisciplinary and multidisciplinary teams.
- 2. Compare and contrast the precepts of palliative care with the hospice model of care; discuss the merging of hospice nursing with palliative care nursing; envision the type of care that will be offered.
- 3. Develop the character of a hospice/palliative care nurse for a television movie. Include:
  - Personal and professional characteristics of the nurse.
  - Roles and responsibilities.
  - Care settings.
  - Ways of collaborating with other health professionals.
  - Situations in which the nurse would assume a leadership role.
