#### Christine Argenbright, PhD, RN

James Madison University

Dr. Argenbright is a tenured Associate Professor and the coordinator of the Clinical Nurse Leader and Nurse Administrator concentrations at James Madison University, Harrisonburg, Virginia. With over 30 years in nursing, Dr. Argenbright previously served as a critical care nurse, case manager, Director of Quality and Risk Management, and hospital administrator. Dr. Argenbright holds a diploma in nursing and a BSN and Ph.D. in nursing from the University of Arizona. Dr. Argenbright's area of expertise is in leadership and guality and safety education. Dr. Hacker is committed to advancing symptom science and promoting guality of life outcomes in people with cancer. Dr. Hacker's progressive research program focuses on fatigue, physical activity, exercise, and quality of life in people receiving intensive cancer treatment. Over the past 10 years, she has conducted multiple clinical trials testing physical activity and exercise interventions in hematopoietic stem cell transplantation recipients. To promote exercise adherence, Dr. Hacker strategically designed pragmatic exercise interventions that were seamlessly into clinical practice. She has led efforts to systematically characterize persistent fatigue in hematopoietic stem cell transplantation survivors; advancing symptom science. She developed a novel methodology to examine the temporal, dynamic relationship between real-time fatigue and free-living physical activity in real-world settings. Her research has been funded by the American Cancer Society, National Cancer Institute, National Institute of Nursing Research, and Oncology Nursing Society. Her work has been published in leading cancer journals.



#### Mary Haras, PhD, MBA, APN, NP-C, CNN

Georgetown University

Dr. Haras is an Associate Professor and Chair, Department of Advanced Nursing Practice in the School of Nursing & Health Studies at Georgetown University in Washington, DC.
