
Gina Clarkson, PhD, APRN, NNP-BC

Interim Associate Dean and Director of the SON Idaho State University



In addition to leading over 60 faculty as Department Chair, Dr. Hershberger has built upon her clinical practice as a Board-Certified Family Nurse Practitioner to lead transdisciplinary research teams to advance knowledge about decision making among individuals and families who interface with reproductive technologies to create scalable digital health interventions (e.g., "TELL Tool") to improve the health and well-being of families across generations. She investigates measures to improve emergency preparedness and response among health care professionals and preparedness levels among vulnerable citizens. Dr. McNeill is involved in studies to determine the prevalence of COVID-19 among various populations, the impact of COVID-19 on the lives of participants, and how antibody levels change over time.
