As Congress returns to their respective states and districts during the August recess, it is increasingly important that your federal policymakers hear from you. Connect with your legislators to discuss important topics currently impacting your community and our nation.

### What is August Recess?

Traditionally, when Congress is "in session," legislators are working in our nation's capital, Washington D.C. When Congress is "in recess," legislators are typically working in their home states and districts connecting with constituents and gaining critical insight on the issues impacting their day-to-day life. As we continue to elevate the needs of academic nursing, August recess provides an opportunity for you to meet with your Members of Congress.

### Three Ways to Connect with your Member of Congress

#### View Hybrid Events and Livestreams

Many Members of Congress are taking part in virtual and in-person events and online livestreams to discuss important topics. These can be found on their official website and social media accounts.

#### Request a Site Visit

Submit a request to your Member of Congress asking for a virtual or in-person tour of your program. This is a great opportunity for federal legislators to see firsthand how academic nursing is preparing the nation's nursing workforce to combat current and future health challenges.

#### Attend a Virtual, In-Person, or Telephone Town Hall

Attending town hall meetings or in-person events gives you an opportunity to ask questions and receive updates on important topics affecting your state or district. These can be found by looking at your federal legislators' website.
