Dear Speaker Pelosi, Leader Schumer, Leader McConnell, and Leader McCarthy,

Throughout the pandemic and other public health challenges, we have witnessed how a welleducated nursing workforce is instrumental in sustaining nursing pathways. Support for nursing schools, faculty, and students is needed now more than ever. The American Association of Colleges of Nursing (AACN) serves as the national voice of academic nursing and represents more than 850 schools of nursing at public and private universities, who educate more than 565,000 students and employ more than 52,000 faculty.<sup>1</sup> Collectively, these institutions graduate our nation's registered nurses (RN), advanced practice registered nurses (APRNs), educators, researchers, scientists, and providers.

As we near the end of the 117<sup>th</sup> Congress and continue our work to improve our nation's health, we strongly urge Congress to include the following appropriations and legislative priorities in any year-end package.

## Support Increased Funding for Nursing Workforce Development and Research

It is essential that Congress swiftly pass a fiscal year (FY) 2023 Omnibus, and include the following funding requests as outlined in the House Appropriations Committee-passed Labor, Health and Human Services, Education, and Related Agencies bill:

- At least \$324.472 million for Nursing Workforce Development programs (Title VIII of the Public Health Service Act [42 U.S.C. 296 et seq.]),<sup>2</sup> and
- At least \$208.571 million for the National Institute of Nursing Research (NINR) from within the overall National Institutes of Health (NIH) funding level.<sup>3</sup>

## Invest in Nursing Education Pathways: Pass the Future Advancement of Academic Nursing (FAAN) Act (S. 246/H.R. 851)

As we evaluate lessons learned from COVID-19, we recognize that investment in academic nursing is imperative in addressing immediate educational needs, while preparing future nursing leaders to

- Enroll and retain nursing students;
- Hire and retain a diverse faculty to educate and prepare the future nursing workforce;
- Support schools of nursing, in partnership with facilities that provide health care, to establish or expand clinical education; and
- Provide other infrastructure support for nursing schools, faculty, and students.

We appreciate your recognition of how vital nursing education, the workforce, and research is to communities throughout the country, including rural and underserved areas. As we near the end of this Congress, including the above priorities in any legislative package is crucial.
