Dear Majority Leader Thune and Minority Leader Schumer,

We, the undersigned organizations, are writing to express our support for the *Non-Opioids Prevent Addiction in the Nation (“NOPAIN”) for Veterans Act*, S. 3209, introduced by Senators Shelley Moore Capito (R-WV), Jeanne Shaheen (D-NH), Katie Britt (R-AL), Catherine Cortez-Masto (D-NV), Kevin Cramer (R-ND), Kirsten Gillibrand (D-NY), Bill Hagerty (R-TN), John Hoeven (R-ND), Jim Justice (R-WV), Tim Kaine (D-VA), Mark Kelly (D-AZ), Amy Klobuchar (D-MN), Pete Ricketts (R-NE), Jacky Rosen (D-NV), Tim Scott (R-SC), and Chris Van Hollen (D-MD).

Currently, too many Americans with Veterans Affairs’ health benefits lack access to many FDA-approved, safe, and effective non-opioid approaches because of overly restrictive practices of the Veterans’ Affairs National Formulary (“VANF”). The small number of non-opioids on the VANF, and the onerous process for accessing non-opioids not on the formulary, create complicated barriers. Unfortunately, this leaves VA patients with little choice in managing their acute pain and many are steered towards prescription opioid pills, which carry with them certain risks, including misuse, abuse, dependence, and addiction.

Following the passage of the *NOPAIN Act* in 2022, Medicare now pays separately for a host of non-opioids – making them more accessible than ever for patients undergoing an outpatient surgical procedure. Unfortunately, the VANF currently only makes a small handful of such approaches accessible to VA beneficiaries, creating a two-tiered system.

Through coordinated action and hard work by government agencies, healthcare providers, advocacy organizations, Congress, state governments, and others, we are seeing a concerted effort to reduce excessive opioid prescribing in the United States. While we know that the VA is committed to doing the same, the agency’s own practices limit their ability to optimize patient choice. By refusing to cover a variety of non-opioid options, clinicians may need to rely on prescription opioids, leading to unnecessary persistent opioid use among VA patients. In some instances, it may result in addiction, overdose, or even death.

We believe it is especially important to work to prevent opioid addiction in a community that faces unique risks for developing an opioid use disorder.

Drug overdose deaths among veterans are increasing. From 2010 to 2019, drug overdose mortality rates among veterans increased by 53 percent.¹ The VANF’s decision to limit options for non-opioids for acute pain exacerbates the unique challenges veterans face. Consider:

- Two-thirds of all U.S. veterans report experiencing pain following their deployments;

- Nearly half report misusing prescription opioids; and ^{2 3}
- In 2020, 2.4 million, or 12 percent, of our veterans reported having a substance use disorder, with approximately 500,000 of them opioid-related.⁴

Veterans also experience high rates of mental health disorders such as depression, anxiety, suicidality, and post-traumatic stress disorder, often using opioids or other substances to cope with emotional pain. Unfortunately, this increases the likelihood that some may progress to illicit drugs, such as heroin, fentanyl or other controlled substances.⁵

As a result, it is critically important that we give clinicians more options to manage our veteran’s acute pain, including non-addictive approaches, to minimize unnecessary exposure to opioids.

The *NOPAIN for Veterans Act* will require the VA to add all FDA-approved non-opioid acute pain management approaches to the VANF. This legislation will facilitate choice in how VA beneficiaries manage their postsurgical pain, reduce rates of opioid abuse, misuse, dependence, and addiction occurring postsurgically, and save lives.

We believe the men and women who serve our country as part of our Armed Services deserve the best of us. This includes setting them up for success after their service. In honor of the sacrifices these brave men and women have made on behalf of our country, we have a duty and a responsibility to ensure they receive the best health benefits we can provide. This includes ensuring they can access the full range of non-opioid analgesic products after surgery.

Accordingly, we implore Congress to swiftly pass the *NOPAIN for Veterans Act*.
