Dear Speaker Johnson, Leader Thune, Leader Schumer, and Leader Jeffries,

On behalf of 62 undersigned organizations representing the Nursing Community Coalition (NCC), we urge Congress to cosponsor and advance bipartisan legislation that positively impacts our current and future nurses, Advanced Practice Registered Nurses (APRNs),<sup>1</sup> nurse leaders, boards of nursing, faculty, and scientists. The NCC represents a cross section of education, practice, research, and regulation within nursing. As the largest segment of the health care profession,<sup>2</sup> and as the most trusted profession,<sup>3</sup> Congress' support of the nursing workforce is crucial to ensuring that patients have access to high quality and timely care.

Specifically, we ask that you advance the following bipartisan legislative priorities that directly impact nursing education, workforce, and research:

- Provide maximum federal funding for all Title VIII Nursing Workforce Development
  Programs and the National Institute of Nursing Research (NINR) in fiscal year (FY)
  2026. This funding should be, at a minimum, consistent with the allocations outlined
  in the bipartisan FY 2026 Labor, Health and Human Services, and Education
  Appropriations bill passed by the Senate Appropriations Committee, which includes:
  - At least \$303.472 million for Title VIII Nursing Workforce Development Programs (Title VIII of the Public Health Service Act [42 U.S.C. 296 et seq.]). As the largest dedicated federal funding for nurses, the Title VIII Programs are

smart investments that bolster and sustain the nation's nursing pipeline by addressing all aspects of nursing workforce demand. This funding supports:

- Those studying to become our nation's APRNs, nurse educators, administrators, public health nurses, and other nurses requiring a master's or doctoral degree.
- Bridge programs, accelerated nursing degree programs, and other activities that help bolster recruitment and retention of students into the nursing profession.
- Schools of nursing, academic health centers, nurse-managed health clinics, state and local governments, and healthcare facilities as they meet shifting demands in health care through innovative programs.
- Scholarships and loan repayment for nursing students and nurses entering practice where healthcare facilities have a critical shortage of nurses.
- Graduate students committed to serving as faculty members to educate the next generation of nurses.
- At least \$197.693 million for NINR: As the only institute or center at NIH that directly supports research by nurse scientists, NINR promotes patient-centered care across the life continuum. NINR's scientists and researchers have made groundbreaking, lifesaving discoveries in the areas of prevention and care for low birthweight in infants,<sup>4</sup> symptom management for those with Alzheimer's,<sup>5</sup> and reducing pressure sores through the development of the Braden Scale.<sup>6</sup> The translational research by our nation's nurses and scientists throughout NIH and at NINR is essential to developing new evidence-based practices to care for all patients. Nurse researchers and scientists bring a unique perspective as they continue their work at the forefront of disease prevention, patient care, and recovery.

Committees of Jurisdiction: House and Senate Appropriations Committees.

## • Title VIII Nursing Workforce Reauthorization Act of 2025 (S.1874/H.R.3593):

Reauthorizes these vital nursing workforce programs at current funding levels so we can continue to bolster nursing education, support institutions that educate future nurses, and help recruit and retain the nursing workforce. This bipartisan reauthorization is essential to ensuring these programs remain and demand for nursing care is met throughout the nation.

Committees of Jurisdiction: House Energy and Commerce Committee, Senate Health Education, Labor, and Pensions Committee.

 Providing Real-world Education and Clinical Experience by Precepting Tomorrow's (PRECEPT) Nurses Act (S.131/H.R.392): Supports clinical education by providing a \$2000 tax credit to those who serve at least 200 hours as a clinical preceptor to nursing

students, advanced practice nursing students, or newly hired licensed nurses, with specific emphasis on those in a Health Professional Shortage Area.

Committees of Jurisdiction: House Ways and Means Committee, Senate Finance Committee.

- Improving Care and Access to Nurses (I CAN) Act (S.575/H.R.1317): Removes outdated barriers in the Medicare and Medicaid programs that currently prevent APRNs from practicing to the full extent of their education and clinical training.
   Committees of Jurisdiction: House Energy and Commerce and House Ways and Means Committees, Senate Finance Committee.
- Nurse Corps Tax Parity Act of 2025 (S.1548/H.R.3145): Creates tax parity for Nurse Corps. Unlike other programs, such as the National Health Service Corps (NHSC), the Nurse Corps is subject to federal taxes. This bipartisan legislation would create parity among these vital federal programs.
   Committees of Jurisdiction: House Ways and Means Committee, Senate Finance Committee.
- Workplace Violence Prevention for Health Care and Social Service Workers Act
  (S.1232/H.R.2531): Works to specifically address the startling realities of workplace
  violence by directing OSHA to put forth enforceable safety standards.
  Committees of Jurisdiction: House Education and the Workforce, House Energy and
  Commerce, and House Ways and Means Committees, Senate Health Education, Labor,
  and Pensions Committee.
- Improving Access to Workers' Compensation for Injured Federal Workers Act (H.R.3170): Retires outdated barriers in the Federal Employee's Compensation Act (FECA) that limit the ability of NPs to diagnose and oversee the care and treatment of federal employees who are injured or become ill in the course of their employment. Committee of Jurisdiction: House Education and Workforce Committee.
- Ensuring Veterans Timely Access to Anesthesia Care Act (H.R.2234): Removes
  unnecessary barriers to care within the Veterans Health Administration (VHA),
  increasing access to care, decreasing wait times, lowering costs, and maintaining the
  highest level of care for veterans.
   Committee of Jurisdiction: House Veterans' Affairs Committee.
- National Nursing Workforce Center Act of 2025 (S.1482): Creates a pilot program to help establish or expand state-based nursing workforce centers and requires the Health Resources and Services Administration (HRSA) to establish a center focused on nursing. Committee of Jurisdiction: Senate Health Education, Labor, and Pensions Committee.
- Midwives for Maximizing Optimal Maternity Services (MOMS) Act (S.1599): Supports
  the establishment or expansion of accredited midwifery programs at institutions of
  higher education and nursing schools.
   Committee of Jurisdiction: Senate Health Education, Labor, and Pensions Committee.

Comprised of nearly five million licensed RNs, APRNs, and nursing students, the profession embodies the drive and passion needed to ensure the health of patients, families, and our country continues to improve. <sup>7</sup> Supporting the current and future nursing workforce is essential, especially given their impact on the healthcare system and to the public health of our nation, especially in rural and underserved areas. Therefore, we urge you to support, cosponsor, and advance these bills this Congress.
