# **HIGHLIGHTS OF THE YEAR**

### July 2019

The AACN Board of Directors approved the creation of a new philanthropic enterprise called the Foundation for Academic Nursing to launch in January 2020.

#### August 2019

35 members of AACN's Diversity, Equity, and Inclusion Group (DEIG) met at AACN's offices in Washington, DC to consider opportunities and challenges to creating inclusive learning environments.

#### September 2019

AACN announces the recipients of its 2019 awards for novice faculty teaching in didactic and clinical settings, faculty who advance innovation and excellence, and faculty who advance the scholarship of teaching and learning.

#### October 2019

AACN hosts its 50th Anniversary Gala at the Library of Congress and continues the celebration at the Academic Nursing Leadership Conference where noted historian Doris Kearns Goodwin gave the keynote address.

#### November 2019

AACN presented a program session titled *Insights on Becoming a Nurse Educator* at Sigma Nursing's biannual convention held at Maryland's National Harbor.

#### December 2019

In collaboration with National Institute on Drug Abuse, AACN awards \$10,000 in grant funding to support the work of graduate students focused on research, dissemination, and adoption of evidence-based substance use disorder treatment practices.

#### January 2020

AACN President/CEO Deborah Trautman presented at the National Advisory Council for Nursing Research where she shared the latest data on the PhD in nursing with government stakeholders and the larger community of interest.

#### February 2020

AACN facilitated bipartisan resolutions in the House and Senate supporting the goals and ideals of the *International Year of the Nurse and the Midwife* as identified by the World Health Organization.

#### March 2020

AACN released Considerations for COVID-19 Preparedness and Response in U.S. Schools of Nursing, which offered recommendations to member schools moving forward with plans to address the COVID-19 outbreak in the community and on campus.

#### **April 2020**

The Foundation for Academic Nursing launched the COVID-19 Nursing Student Support Fund, which provided financial support to students whose education and lives were impacted by the pandemic.

#### May 2020

AACN launched the Gallery of Leadership, which features videos from nursing deans who shared insights on how their schools and the larger nursing community were addressing COVID-19.

#### June 2020

AACN released a new statement titled *Academic Nursing's Call for Liberty and Justice for All,* which called for an end to systemic racism and pervasive inequities in our society.

## LETTER FROM THE BOARD CHAIR AND PRESIDENT/CEO



#### **Moving Together to Meet the Challenge**

AACN is proud to serve our community of academic nursing leaders and students whose heroic efforts this year helped to ensure that our nation remained healthy and strong despite the challenges presented by the Coronavirus. Throughout the country, schools of nursing took decisive action to protect students, faculty, and communities; all while adapting their programs to sustain a robust nursing workforce.

Soon after the association's 50th anniversary celebrations ended in 2019, AACN's priorities shifted to coordinating academic nursing's response to COVID-19 at the national level. AACN's Board and staff engaged in active collaboration with a wide community of stakeholders whose interests cover nursing education, research, practice, licensure, accreditation, and regulation. We advanced our federal advocacy strategy to focus on legislation and funding offered to protect and sustain the nation's nursing workforce at this critical time. AACN worked closely with the heads of the other national health profession organizations to ensure that our priorities and messaging was timely, consistent, and complementary.

Lessons learned from the pandemic are many. We gained a greater appreciation for the importance of having a closely connected academic nursing community. Schools across the country helped overcome challenges by sharing strategies, contingency plans, and exemplars on how to sustain quality nursing education programs given these extraordinary times. Academic and practice leaders came together to ensure continuity in clinical education and to think creatively about how to deploy students safely in a public health emergency. This crisis also highlighted the need to integrate preparedness for disasters into nursing curricula. Conversations about how to achieve this goal have been part of AACN's work to re-envision the *Essentials*.

Together, AACN deans, faculty, and students will weather these challenging times and grow stronger as a community of leaders.






## **AACN'S DATA COLLECTION**

### Introducing **FOUNDATION FOR ACADEMIC NURSING** AMERICAN ASSOCIATION OF COLLEGES OF NURSING

Approved by the Board of Directors in July 2019, AACN launched a new foundation to serve as a focal point for the association's fundraising efforts while elevating the importance of academic nursing and our member schools in the philanthropic community.

The Foundation for Academic Nursing was established in January 2020 as an internal division within AACN designed to coordinate and disseminate all sources of grant funding to member schools in support of the association's mission and strategic goals.

This year, the foundation launched two programs that provide support to nursing students and faculty, including:

- The COVID-19 Nursing Student Support Fund, which provides financial support to students whose education and lives have been directly impacted by the coronavirus. The fund was created in April following a \$25,000 donation from philanthropist Darlene Curley and provides one-time grants to students enrolled in AACN member schools who need support to complete their education and/or meet life expenses. In May, 51 awards were made to students in every state plus the District of Columbia. In June, AACN announced that additional support for this fund was received from 24 individuals and organizations, including the Morton K. and Jane Blaustein Foundation (\$25,000); Jonas Nursing and Veterans Healthcare (\$10,000); and the University of Memphis Foundation (\$3,000).
- The AACN Faculty Scholars Grant Program provides funding to nurse educators whose scholarly activities reflect current issues in nursing education or practice and support AACN's strategic priorities. The AACN Board of Directors approved this grant program to spotlight the innovative work led by nurse educators to redesign teaching and learning at member schools. Funding for this program was provided by more than **150 nursing schools and organizations** that contributed to AACN's 50th Anniversary Celebration program. Through this initiative, the Foundation will grant **\$100,000** in funding to support **four \$25,000** faculty projects through 2022. Two awards were offered in the 2020-2021 academic year, and two will be offered in the 2021-2022 academic year.

## DRIVING INNOVATION AND EXCELLENCE Strategic Goal #1

The association's work to transform academic nursing and chart the future of nurse education falls under our first strategic goal, which states that **AACN is the driving force for innovation and excellence in academic nursing.** 

The **Essentials Task Force** moved forward with its work this year to re-envision nursing education and the competency expectations of graduates from baccalaureate, master's, and Doctor of Nursing Practice programs. To help build awareness and consensus around the new *Essentials*, AACN organized the first National Faculty Meeting from November 2019 to January 2020 to encourage discussion at schools nationwide about the future of nursing education. More than 300 schools of nursing conducted faculty meetings and provided feedback on the *Essentials*. AACN also hosted two regional meetings to collect feedback on the draft entry-level competencies in San Antonio in February and in Atlanta in March. Due to the pandemic, the regional meetings to discuss the advanced-level competencies where held virtually with three session offered in June with over 400 faculty and deans attending.

AACN continued its work this year to advance the **Clinical Nurse Leader (CNL®)** role as the key to improving care coordination, minimizing risks, advancing quality improvement strategies, and implementing evidence-based solutions at the point of care. By the end of the fiscal year, a total of 8,017 program graduates completed the certification process developed by the Commission on Nurse Certification (CNC) and are now certified CNLs.

The **End-of-Life Nursing Education Consortium** (ELNEC), a thriving partnership between AACN and City of Hope, is focused on improving the care of patients with serious illness and their families. ELNEC was launched in 1999 with initial funding from the Robert Wood Johnson Foundation as a faculty development initiative designed to improve palliative care. Since its inception, this initiative has reached nurse educators in all 50 states and 100 countries worldwide. To date, more than 738,000 nurses serving as clinicians, administrators, educators, and researchers have benefitted from ELNEC education. This project continues to expand after 21 years thanks to contributions from 13 foundations, organizations, and government agencies.

Now in its 10th year, **NursingCAS** is the nation's only centralized application service for students applying to nursing programs at all levels. This year the service generated over 123,000 applications to more than 250 participating schools. Nursing CAS simplifies the application process for prospective nursing students, streamlines administrative tasks for admissions teams, and provides a much-needed source of data to better understand trends in nursing education. This year, a greater emphasis was placed on helping schools understand how to utilize NursingCAS for holistic admissions review. ## IMPROVING HEALTH, HEALTH CARE AND HIGHER EDUCATION

### Strategic Goal #2

AACN's goal to serves as a **leading partner in advancing improvements in health, health care, and higher education** extends to our leadership development programming, federal advocacy agenda, and member education.

Designed to provide a variety of learning opportunities to all individuals along the leadership continuum, from novice faculty to seasoned administrators, **AACN LEADS** offers a portfolio of programs for new, early career, and experienced deans, associate deans, program directors, and faculty. Programs available to members include:

- Designed for aspiring deans and senior faculty,
   Elevating Leaders in Academic Nursing (ELAN)
   provides participants with a year-long focused
   assessment experience, a range of content and
   exercises related to successful executive
   leadership, and the opportunity to establish a
   peer network that fosters long-term partnerships
   and collegial support.
- Geared toward new and transitioning deans,
   Advancing Academic Leadership for New
   Deans is an intensive 13-month experience that includes an in-depth skills assessment, a series of in-person meetings, and a personalized leadership development project.

• MentorLINK: Connecting for Success brings experienced deans together with new and early career deans looking for advice on how to overcome challenges and maximize their impact in an interprofessional academic environment.

In addition to AACN LEADS, the association provides leadership development opportunities throughout our programming. Here are a few numbers that helped to define our success this year.

- More than 8,000 students in master's and doctoral programs were enrolled in the Graduate Nursing Student Academy (GNSA), which provides high-value programs, resources, and services to meet the professional development of student leaders.
- 1,600 nursing school faculty and staff at member institutions have joined AACN's
   Leadership Networks, which provide an invaluable link to peer professionals at nursing schools nationwide. Networks include
   Organizational Leadership, Faculty Leadership, Research Leadership, Practice Leadership, Business Officers of Nursing Schools, Nursing Advancement Professionals, and Graduate Nursing Admissions Professionals.

## IMPROVING HEALTH, HEALTH CARE AND HIGHER EDUCATION

### Strategic Goal #2

In the **government affairs arena**, AACN is a recognized leader and authority on policies impacting nursing education, research, and practice. With the onset of the pandemic, AACN focused its advocacy work on providing new resources and support for schools of nursing.

- On March 16, 2020, AACN's President and CEO Deborah Trautman was invited to a <u>White House</u> <u>briefing</u> with President Donald Trump, Vice President Mike Pence, and members of the Coronavirus Task Force. Dr. Trautman presented information on the critical role nurses play in preventing the spread of COVID-19 and discussed what support was needed to keep the nursing workforce safe and fully engaged in treating patients.
- On March 27, 2020 the President signed into law H.R. 748, the Coronavirus Aid, Relief, and Economic Security (CARES) Act. This \$2 trillion historic legislation contained many of AACN's legislative priorities and key provisions, including reauthorizing the Title VIII Nursing Workforce Development Programs; ensuring the safety and health of nurses and nursing students; safeguarding federal student loans and aid; authorizing nurse practitioners and clinical nurse specialists to certify home health care for their patients; and modernizing the United States Public Health Service Commissioned Corps:

Pre-pandemic highlights this year include:

• In November 2019, Dr. Nancy Fahrenwald, dean of the Texas A&M University College of Nursing,

presented testimony on behalf of AACN before the House Committee on Small Business on the role of innovation in academic nursing. Dr. Fahrenwald, who serves as Chair of AACN's Government Affairs Committee, discussed how her school is using clinical simulation to augment its nursing curriculum.

 In December 2019, AACN and the National Institute of Drug Abuse announced that Monjama Korngor, a DNP student from Widener University, was selected to receive a \$10,000 Substance Use Disorders Evidence-Based Practice Training Award.

AACN is the **preferred provider of professional development opportunities** for deans, faculty, and students from baccalaureate and higher degree programs. In addition to more than **40 free webinars** offered throughout the year, AACN presented a variety of conferences and network programs through February 2020. To keep members safe, all conferences offered in March or later were postponed or held virtually due to the pandemic.

## ADVANCING DIVERSITY AND INCLUSION Strategic Goal #3

Our third goal - AACN is a primary advocate for advancing diversity and inclusion within academic nursing – underscores the association's commitment to promoting a diverse nursing workforce, creating inclusive learning environments, and ending structural racism.

- This year, AACN continued to provide technical assistance to 32 nursing schools that received funding through the Nursing Workforce Diversity (NWD) program offered by the Health Resources and Services Administration (HRSA) to implement a **Holistic Admissions Review** process. AACN developed a structured NWD Technical Assistance Program that features an assessment of admissions practices, an on-site Holistic Admissions Review workshop, student recruitment and retention strategies, and models for building a successful mentoring program.
  - As part of AACN's work with the HRSA grantees, AACN developed LAMP: Learning Across Multidimensional Perspectives, a Culture and Climate Survey for Nursing Schools. This tool was created to assess the general perceptions of students, staff, and faculty on institution-wide program implementation efforts around diversity and inclusion. AACN staff have used this tool to evaluate educational innovation and transformation at the HRSA-funded schools. After the testing period, AACN will make this survey instrument available to other schools.
  - In August 2019, AACN held the inaugural meeting of its Diversity, Equity, and Inclusion Group (DEIG) at our headquarters in Washington, DC. Consisting of 62 representatives from member schools, this advisory group is comprised of individuals with expertise, knowledge, and experience in advancing innovative approaches to enhancing diversity and inclusion in academic nursing and the workforce. The first meeting was attended by 35 DEIG members who helped to identify effective methods for advancing diversity, equity, and inclusion.
  - In June 2020, AACN leadership issued a statement to AACN members and external stakeholders in response to the tragic killing of George Floyd. Titled *Academic Nursing's Call for Liberty and Justice for All*, AACN called for an end to systemic racism and pervasive inequities in our society. The statement culminates with these words: "As the calls for meaningful change grow louder, nurse educators will do our part to speak out, take action, and create a preferred future that everyone so justly deserves. Together we will catalyze support for our nation's promise of liberty and justice for all."
  - This year, AACN continued its collaboration with the National Institutes of Health to promote the *All of Us Research Program*, which is seeking greater representation from historically underrepresented communities in biomedical research. Through this initiative, AACN member schools of nursing and their community partners who commit to increasing awareness of the All of Us Research Program can receive up to \$10,000 in funding to augment their local efforts. Since 2017, AACN has awarded \$330,000 to 32 nursing schools.

### **INFORMATION AND CURATION SYNTHESIS** Strategic Goal #4

The fourth pillar of the association strategic plan calls for AACN to serve as the **authoritative source of knowledge to advance academic nursing through information curation and synthesis**. A major focus of our communications work this year centered around providing resources and weekly updates related to supporting members during the pandemic.

As the national voice for academic nursing, AACN strives to bring the association's mission and message before the larger nursing community. Communication highlights include:


- In December 2020, AACN endorsed a new white paper titled **Promising Practices in Holistic Admissions Review: Implementation in Academic Nursing**. This document provides a detailed roadmap for schools looking to recruit more students from underrepresented groups into the nursing profession using evidence-based strategies and admissions redesign.
- The *Journal of Professional Nursing* had another successful year with 564 manuscripts received and a 24% acceptance rate. The journal's Impact Factor, which measures the frequency with which the average article in a journal is cited in a particular year, increased dramatically in 2019, from 1.82 to 2.05. The journal's five-year Impact Factor is 2.13.
- AACN's website www.aacnnursing.org continues to be a primary channel for communication with members and external stakeholders. With more than 6.3 million page views and 1.9 million user sessions, the website contains more than 900 pages and 1,200 downloadable documents and resources.
- With more than 45,000 subscribers, **AACN News Watch** is a weekly email advisory covering the latest news, emerging trends, funding opportunities, and new resources of interest to members and the larger academic nursing community. Special emphasis is placed on covering AACN's leading initiatives, including political advocacy efforts, publications, conferences, collaborations, and other activities aimed at meeting the member information needs.
- AACN strengthened its social media presence this year through enhanced content and focused outreach initiatives using a variety of platforms, including Twitter, LinkedIn, Facebook, YouTube, and Instagram.

## AACN'S RESPONSE TO COVID-19

Beginning in February 2020, AACN began its work to coordinate academic nursing's response to COVID-19 at the national level. AACN's Board and staff leaders engaged in active collaboration with a wide community of stakeholders whose interests cover nursing education, research, practice, licensure, accreditation, and regulation.



To assist nursing schools transitioning to remote learning, AACN developed several documents to provide guidance, including *Considerations for COVID-19 Preparedness and Response in U.S. Schools of Nursing*. This document offers recommendations related to didactic and clinical education, student travel, alternate teaching approaches, and additional resources for faculty and students.

To meet the information needs of constituents, AACN created an online information clearinghouse on **Coronavirus Resources for Nurse Educators**, which is updated daily and features current information and new opportunities for faculty and students; discussion threads; guidance related to diversity and inclusion; and a detailed FAQ resource.





AACN worked with academic and industry leaders to launch the free **COVID-19 Response Webinar Series** focused on teaching and online learning, crisis leadership, innovations in clinical education and simulation, maintaining enrollments, and sustaining mental health. The popular series was open to all nurse educators across all program types.

AACN's Foundation for Academic Nursing launched the **COVID-19 Student Support Fund**, which has collected and disbursed more than \$60,000 in scholarship support to students in need this year.



## AACN'S RESPONSE TO COVID-19

Continued



AACN staff worked to advance the association's **federal advocacy strategy** with a focus on legislation and funding that will protect and sustain the nation's nursing workforce at this critical time.

AACN **engaged with stakeholders** in health care and higher education to shape policies and statements needed to advance academic nursing priorities during the pandemic. This work included collaborating with 15 national nursing organizations on a *Statement Regarding Nurse Practitioner Students and Direct Care Clinical Hours and the National Council of State Boards of Nursing* and 8 other organizations on a policy brief supporting the formation of academicpractice partnerships to meet education and workforce needs.





In April 2020, AACN President/CEO Deborah Trautman began a coordinated **outreach effort to member deans** to find out more about how schools were faring during the pandemic and to determine how AACN could be most helpful. Attention was given to reaching a wide cross-section of members from various types of programs, including small, private, public, and academic health center-affiliated schools of nursing.

#### **CCNE** Response to the Pandemic

The Commission on Collegiate Nursing Education (CCNE), AACN's autonomous accrediting arm, ensures the quality and integrity of baccalaureate, graduate, and residency programs in nursing. To date, 92% of AACN member schools are affiliated with CCNE as either accredited or new applicant programs.

In March 2020, CCNE issued sets of guidance, one for accredited baccalaureate and graduate programs and one for residency programs, that addressed questions related to meeting accreditation standards while adapting programs in response to the pandemic. These statements provided new guidance to CCNE-affiliated schools related to didactic coursework, clinical learning experiences, and substantive change notifications.

## **PARTNERSHIPS & COLLABORATIONS**

Across all of our strategic goals, AACN seeks collaboration and synergy with a wide community of stakeholders.

- Since 2012, AACN has been partnering with Jonas Philanthropies to enhance the nation's supply of doctorally prepared nurses available to serve in faculty roles and as advanced practice registered nurses. This year, AACN continued to provide administrative support to the latest cohort of 196 Scholars, which includes both Jonas Scholars and Jonas Veterans Healthcare Scholars. The cohort includes 124 PhD students, 65 DNP students, 5 joint PhD/DNP students, and 2 EdD students.
- AACN-AONL Advisory
   Committee developed and
   launched a joint survey to better
   understand the issues around
   payment for clinical preceptors.
   Full survey results were released in
   May 2020 with the majority of
   schools not currently paying for
   clinical preceptors or clinical
   placement sites.
- In August 2019, the Arnold P. Gold Foundation (APGF) and AACN announced that 50 schools of nursing were selected to receive funding support to host White Coat/Oath Ceremonies. Since 2013, AACN and APGF have collaborated to provide support and technical assistance to 360 schools of nursing in 49 states to offer ceremonies designed to inspire a commitment to providing compassionate care among students entering the nursing profession.

- The Vizient-AACN Nurse Residency Program supports new nurses as they transition into their first professional roles. Since 2013, more than 113,000 residents have completed this program, which has been rated highly by graduates and employers. With 560 residency sites in 44 states, the nurse retention rate of first-year baccalaureate graduates was, on average, 93% at residency sites, which is significantly lower than the national average.
- The association continued to play a leading role with the Interprofessional Education Collaborative (IPEC) this year. With AACN President and CEO Deborah Trautman serving as Board Chair, IPEC took action to support its mission to advance interprofessional education and team-based care by offering faculty development institutes, a free webinar series, an Interprofessional Deans Leadership Program, and a joint awards program with the U.S. Public Health Service.
- This year, AACN joined with the DAISY Foundation to issue a National Call for Nurse Faculty Recognition to encourage schools and practice sites to formally recognize nurse educators by using The DAISY Award® for Extraordinary Nursing Faculty. To date, more than 560 nurse educators have been recognized with this distinguished honor.
