Objective

 Discuss the implications of the Consensus Model for APRN Regulation on certification and education



Requirements for Certification

- » Follow established certification testing and psychometrically sound, legally defensible standards for APRN examinations for licensure
- » Assess the APRN core and role competencies across at least one population focus of practice
- » Assess specialty competencies separately from the APRN core, role, and population-focused competencies
- » Be accredited by a national certification accreditation body




Requirements for Certification (cont.)

- » Enforce congruence (role and population foci) between the education program and the type of certification examination
- » Provide a mechanism to ensure ongoing competence and maintenance of certification
- » Participate in ongoing relationships that make processes transparent to boards of nursing
- » Participate in a mutually agreeable mechanism to ensure communication with boards of nursing and schools of nursing



Model for APRN Regulation




* Certification for specialty may include exam, portfolio, peer review, etc.

** Certification for licensure will be psychometrically sound and legally defensible examination be an accredited certifying program,

Certification

- Create new NP certification examinations
 - » Adult-Gerontology Primary Care NP
 - » Adult-Gerontology Acute Care NP
- FNP and WHNP certification examinations to include additional gerontology content
- CNS certification examinations
 - » Adult-Gerontology CNS (new)
 - » CNS certification examinations will test "across the continuum from wellness through acute care"



Certification

- Competencies
 - » Adult-Gerontology Primary Care NP
 - » Adult-Gerontology CNS
 - » Adult-Gerontology Acute Care NP
 - » Recommended Competencies for Older Adult Care for FNP, WHNP, and Women's Health/Gender Specific CNSs



Certification

- Target date for implementation of these new examinations **2013**
- Continue to administer the separate ANP, ACNP, GNP, ACNS, and GCNS certification examination during the transition period
- Retire the separate certification examinations in 2014 or 2015



Implications for Educators

- Graduates must complete the education program that corresponds to the certification
 - » Role and population
 - » 500 clinical hours
- All APRNs must complete three separate comprehensive graduate-level courses in:
 - » Advanced physiology/pathophysiology
 - » Advanced health assessment
 - » Advanced pharmacology



Implications for Educators (cont.)

- Status of your program changes
- Students
 - » Current
 - » Future

• Transcripts

- » Degree conferred
- » Role and population
- » Course titles that reflect the content
