What is August Recess?

Traditionally when Congress is "in session," legislators are working in our nation's capital, Washington D.C. When Congress is "in recess," legislators are typically working in their home states and districts connecting with their constituents and gaining critical insight on the issues impacting their day-to-day life. As we continue to combat this public health challenge, August recess still provides an opportunity to connect with your elected officials, albeit in a digital capacity.

- + Visit your federal legislator's official website where you can sign up for newsletters, see their position on important topics, and more.

Three Virtual Ways to Connect with your Member of Congress

Attend a Virtual or Telephone Town Hall

Attending virtual town hall meetings gives you an opportunity to ask questions and receive updates on important topics affecting your state or district. These can be found by looking at your federal legislator's website.

View Virtual Events and Livestreams

Many Members of Congress are taking part in virtual events and livestreams to discuss their take on important topics. These can be found on their official website and social media accounts.

Request a Site Visit

Submit a request to your Member of Congress asking for a virtual or a potential in-person tour of your program. This is a great opportunity for federal legislators to see firsthand how academic nursing is preparing our future nursing workforce to combat current and future health challenges.
